

1. Introduction

2. Personal Data

Types of personal data collected:

- **User Information:** Names, email addresses, phone numbers, addresses, company information (registration details, address, governance structure), financial information (for payment processing)
- **Transporter Information:** Names, contact information, licenses, vehicle information, insurance details
- Shipper Information: Names, contact information, shipment details, cargo information
- **User Activity:** Location data, device information, browsing history, usage data, interactions with our platform and services

Methods of collection:

- Forms during registration, quote requests, and service interactions
- User interactions with our website and app
- Automatic collection through cookies and other tracking technologies
- Direct submission from users and third parties (e.g., shippers, transporters)
